

United Way of Washington County 2021 Campaign Official Sweepstakes Rules

Updated August 23, 2021

1 This promotion includes donations to United Way of Washington County, Inc.'s 2021 campaign received by **4:00 p.m. Central Time December 15, 2021**.

2 As of September 1, 2021, Sweepstakes entrants must be legal residents of Wisconsin, at least 18 years of age, and possess a valid driver's license. Odds of winning depend on number of eligible entries received.

3 Sweepstakes winners will receive one of the following prizes:

A. \$600 in gift cards to Washington County Restaurants

B. \$1,000 VISA gift card

C. 2022 Toyota or equivalent.

D. 1 of 5 - \$500 gift cards to choice of Amazon, Cabela's, Kwik Trip or Meijer.

4 United Way of Washington County, Inc.'s individual donors will be automatically entered in the Sweepstakes based on this criteria:

- For prize A: Any donor who pledges to give \$1 per week for one year, for a total gift of \$52, OR any donor who gives a donation totaling \$52 or more.
- For prize A or B: Any donor who pledges to give \$2 per week for one year, for a total gift of \$104, OR any donor who gives a donation totaling \$104 or more.
- For prize A, B, or C: Any donor who pledges to give \$3 per week for one year, for a total gift of \$156, OR any donor who gives a donation totaling \$156 or more.
- For Bonus Prize: All new or increased donors.

Only pledges/donations to the United Way of Washington County, Inc. general fund or designations to partner agencies are eligible for entry into the Sweepstakes. A designation to another United Way is ineligible for entry.

5 Entry without meeting the automatic entry requirement can also be made by sending a letter to United Way of Washington County, Inc., Attn: Sweepstakes, P.O. Box 304, West Bend, WI 53095-0304, containing name, address, phone number (work, home), date of birth, and current e-mail address. Limit one entry per person. The pledge form or Entry Letter must be received at the United Way of Washington County, Inc. office, located at 1121 E. Sumner Street Hartford, WI 53027 by 4:00 p.m. Central Time on December 18, 2021. United Way of Washington County, Inc. is not responsible for companies that fail to submit their employee's pledge forms/donation information by this date. United Way of Washington County, Inc. is not responsible for lost, stolen, damaged, incomplete, invalid, unintelligible, garbled, delayed, or misdirected entries, all of which will be void.

6 A random drawing of five (5) names will be conducted on or about January 20, 2022 from among all eligible entries received by United Way of Washington County, Inc., whose decisions are final and binding in all matters relating to the Sweepstakes. The five (5) finalists will be invited to attend the United Way Campaign Celebration Event to be held at the West Bend Mutual Prairie Center in February 2021. Finalists must be present to win.

7 Winners will be required to execute an Affidavit of Eligibility, Liability & Publicity Release ("Affidavit") and return to United Way of Washington County, Inc. within ten (10) days from when the notice or attempted notice is sent, in order to claim his/ her prize.
